The purpose of this form is for enrolled Yakama members to request a bison hunting permit for the 2019-2020 bison hunting season. Permit request forms must be received prior to the conclusion of the Bison Hunt Orientation meetings; scheduled for November 9, 12 & 13 & 14, 2019 by the Wildlife Program.

Completing this permit request form does not guarantee you a bison hunting permit. Only permits that have been formally issued by the Fish & Wildlife Committee are valid to participate in the 2019-2020 bison hunting season.

This includes the requirement that hunting teams will consist of at minimum of two enrolled Yakama members that have all attended the 2019-2020 Bison Hunt Orientation.
